Dear patients!

First of all, I would like to thank you very much, also on behalf of my team, for your immense appreciation of our work in the clinic and research.

For clarification: We are stopping because the economic situation in these times forces us to do so. This fact I would like to emphasize.

There will be no succession for continuation of the Institute.

In the following a few answers to questions that are frequently asked.

1. Hamster purchases for creams and Anti-Ox capsules are not possible. We will continue the production under my direction.
However, we depend on the supplier of the base cream.

The situation already escalated in January/February 2020 due to Corona.
From our side, production will continue. Please order exclusively via

Purchases will be sent after receipt of payment.

You will need about 500ml (1 bottle) per 1 month for full body treatment.

Attention! The cream should not be stored in very warm rooms or in the sun.
In case of discoloration it is ineffective.

2. **Anti-Ox capsules:**
Always use 2 capsules per day.
1 x in the morning 1 x in the evening, **during** the meal.
3. **Important: Maintenance of the light equipment:**
All total body devices are maintained by Dr. Hönle.
The tubes can be used for about 7 years.(311nm)
Then they must be replaced.
Remember: Even little used devices are aging with time.

The hand-held device Dermalight 80 should receive new tubes every year. They lose intensity and are then ineffective for your treatment. Please follow the irradiation instructions carefully.

It is essential to watch the distance and the correct positions in order to be successful. It has been explained to you several times in detail.

Please do not increase your irradiation times and irradiate according to the proven scheme.

The irradiation dose of $0.15\text{J}/\text{cm}^2$ (corresponds to 28 seconds for Dermalight 1000) for each directly irradiated body part at a distance of 15 - 20 cm.

The hand-held device (Dermalight 80), has to be put directly on the white skin for 10 seconds ($\approx 0.15\text{J}/\text{cm}^2$) without a comb.

The eye area is irradiated with comb attachment for 33 seconds.

4. Each patient should have the list of tips.
This list contains what I recommend based on my knowledge and what you should avoid. Remember that the chemistry of the active ingredient complex can be rendered ineffective by other chemistry. Therefore I do not recommend using other creams, lotions etc. when using PC-KUS cream.
5. Questions about climato-therapy at the Dead Sea cannot be answered at the moment, because planning under corona conditions is not possible.
If necessary, you will be informed via Internet.
A trip, as it has been under the auspices of the institute, will no longer be offered.
Future planning for a group journey, is still subject of discussion.
